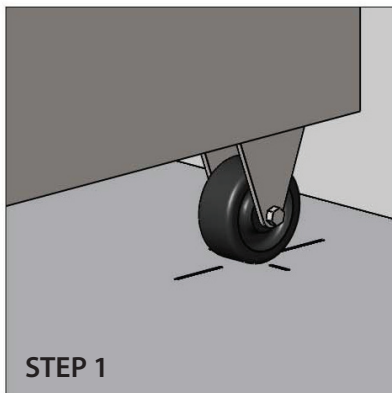
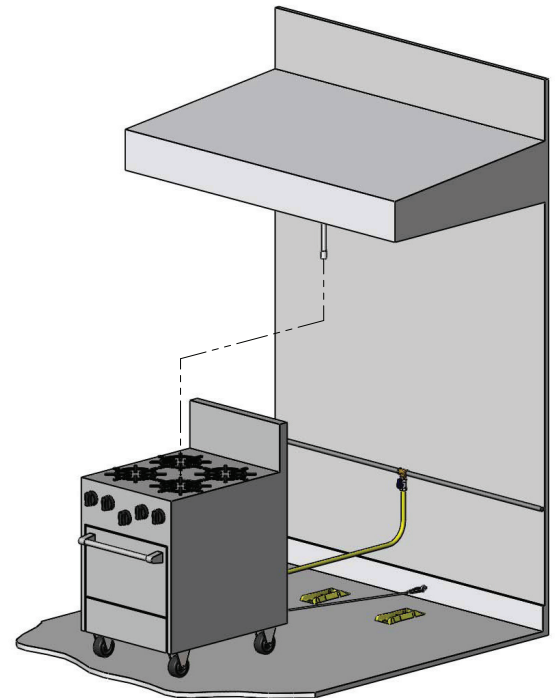
Installation Instructions

Flame-Retardant Wheel Placement System for Commercial Kitchen Equipment

Posi-SetTM is a device that accurately locates wheeled commercial kitchen equipment to a fixed position below the fire suppression system. This device ensures that the clearance required by the National Fire Prevention code or like codes are maintained.

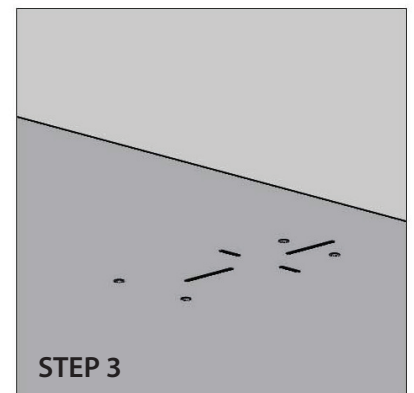
Tools Required:

- Hammer drill with 3/8" masonry bit
- $\varnothing$ 3/8" pin or solid punch
- Clear silicone sealant



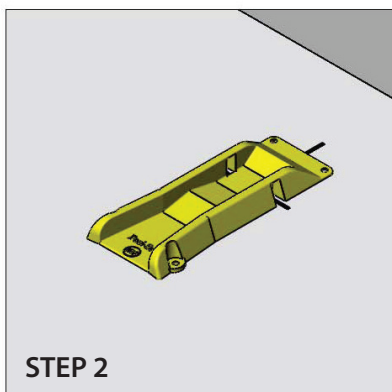
STEP 1:

With the cooking appliance properly positioned beneath the exhaust hood and fire suppression nozzle, mark the horizontal and vertical center of both rear wheels.



STEP 2:

Using a Posi-SetTM device as a template mark the hole locations for the mounting screw anchors (furnished with each pair).

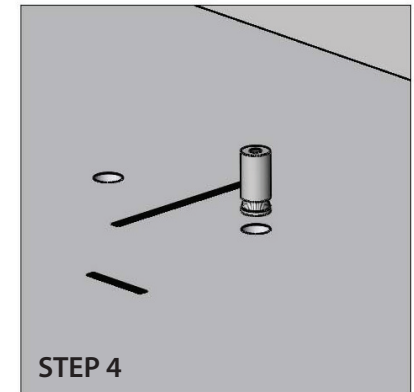


STEP 3:

Drill $\varnothing$ 3/8" x 5/8 inch deep holes. Blow or vacuum out debris from holes.

STEP 4:

Insert the screw anchors with cone end down into the holes.



STEP 5

Using a pin or solid punch, tap the anchors into the holes until set.

STEP 6

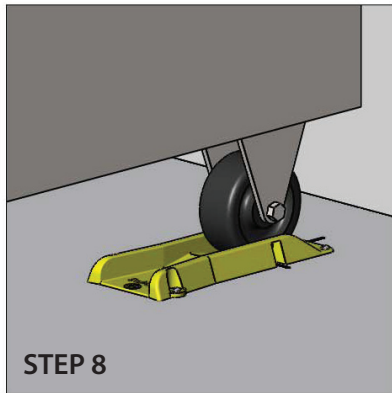
With the floor dry and free of grease and debris, apply a thin bead of silicone sealant around the bottom face of the Posi-Set™ device.

STEP 7

Set Posi-Set™ in place and secure with screws (furnished with each pair).

STEP 8

Move appliance back in place onto the Posi-Set™.



STEP 9

Ensure that the warning label is placed in a visible location on the front of the appliance.
